LAW ENFORCEMENT TRAINING

This marks the eighteenth year in which Law Enforcement Training is operating from the George S. Mickelson Criminal Justice Center. Law Enforcement Training is continuing to improve and expand its programs in order to better serve the needs of local law enforcement agencies throughout the state.

The continuing support of the Commission, Governor, and members of the legislature is very gratifying and will result in improved law enforcement service throughout the state of South Dakota.

Law Enforcement Training provides basic and advanced training to South Dakota law enforcement officers and all 911 telecommunicators. Training is also provided to prosecutors, correctional officers, terminal operators, coroners, school sentinels, and enhanced carry instructors.

The Training Office administers a grant program, which allows local law enforcement agencies to apply for funds to host specific training for officers in their area.

Law Enforcement Training licenses and regulates the activities of private or law enforcement polygraph examiners, and Computer Voice Stress Analyzer (CVSA) examiners. LET also certifies canine teams.

Law Enforcement Training continues to conduct on-site audits of the technical colleges, Lake Area Technical College, Southeast Technical College, and Western Dakota Technical College. Each accredited program as well as the curriculum is reviewed. LET provides each program with feedback to areas that need to be changed as well as recommendations for improvement.

ADMINISTRATION

EXPENDITURES

Total expenditures for Fiscal Year 2022 were \$3,305,331.41. This includes all academy training, field training, in-state and out-of-state training. The money for the South Dakota Law Enforcement Training Program is derived from a portion of the fines paid by violators of the law. The amount of money derived from fines is allocated to the individual program by statute and made available through legislative appropriation.

ACTIVE OFFICERS

STATE - COUNTY - MUNICIPALITIES - TRIBAL

All full-time and part-time law enforcement officers are required to be certified within their first year of employment, including elected officials.

As of June 30, 2022, there are 2,170 active full-time, part-time employed and certified law enforcement officers in South Dakota.

DISPATCH - TELECOMMUNICATOR

There are 343 active certified 911 telecommunicators in South Dakota. There are 2,874 active terminal operators.

CERTIFICATION SESSIONS

There were 145 officers enrolled in the Basic Certification sessions held in FY 22. 132 officers graduated from the Basic Academy. There were two academic dismissals, one dismissed from employing agency, one medical withdrawal, 3 personal illness withdrawals, five were dismissed for misconduct.

This award is given in memory of Agents Coler and Williams who made the ultimate sacrifice ... their lives. The award is based on academics, leadership, ability, and general conduct during the Basic Certification Course. It is the most distinguished award given at the academy.

WILLIAM DAVIS TOP GUN MEMORIAL AWARD



This award is given by the family of William 'Bill' Davis in memory of Deputy William P. Davis, Moody County Sheriff's Office, who made the ultimate sacrifice on November 3, 2003, while serving the people of his community. Deputy Davis was killed by a passing motorist while he was making an arrest at an accident scene. His memory will live on in the hearts of those who carry on his proud tradition.

INSPIRATION AWARD

This class member has exemplified direction in creating an inspiring atmosphere moving others toward professional and personal achievement. Additional attributes include maintaining morale, encouragement, respect, and class service throughout the session.

911 TELECOMMUNICATORS

There were 59 telecommunicators enrolled in the Two-Week Basic Telecommunicator training sessions in FY22. 56 telecommunicators graduated from the training session. There were two academic dismissals and one withdrawal from the sessions.

OUTSTANDING STUDENT AWARD

The Outstanding Student award, sponsored by the South Dakota Peace Officers Association, is based on academics, leadership ability, and general conduct during the Basic Certification Course.
